

AFFIDAVIT	

I. GRAHAM HAWTHORNE of Panatina, Honiara, Solomon Islands, General Manager of Solomon Islands Airways Limited MAKE OATH and say as follows:-

- 1. I am the Manager of Solomon Islands Airways Limited and at present I reside in the Solomon Islands.
- 2. On Sunday 17th May 1988 I met a man who I know as John Smith at the Honiara Hotel by prior arrangement. Several other people were there including including Danny Philips, a former Member of Parliament and Philip Kentwell, from the Australian High Commission.
- We had a general discussion about several matters. During the course of the conversation Smith said that he knew about my case (by which he meant the criminal charges brought against me under Part XVI of he meant the criminal charges brought and without influence in Honiara the Penal code. He said that he was not without influence in Honiara and that if I did something for him in respect (as General Manager of and that if I did something for him in respect of the flights to Anuha, he would solomon Islands Airways) in respect of the flights to Anuha, he would something for me. I informed him that I was not interested in this do something for me. I informed him that I was not interested in this arrangement as I wanted to clear my name through the proper and correct legal process.
- 4. Smith also told me during this conversation that he was a "pilot".

 He seemed to be in a somewhat agitated state and he said that the flights into Anuha were dangerous. I disputed this and said that, if the downward or downwind was less than the demonstrated downwind or the downward or downwind was less than the demonstrated in the cross-wind component of the particular aircraft, as reflected in the aircraft flight manual, then the operation is safe and acceptable. I went into more technical details about the safety of landing at I went into more technical details about the safety of landing at Anuha. Although Smith had said that he was a pilot he did not seem to gasp what I was talking about.
 - 5. Smith went on to say that he wanted all flights to Anuha stopped.

 I advised him that this would be contrary to Solomon Islands Airways
 Licence and would damage our role in tourism development and would
 cause conflict (legal or otherwise) between Solomon Islands Airways
 and the Anuha Resort Management.
 - 6. Smith was very talkative and told me that he had irrevocable power of Attorney over Anuha Island.
 - 7. Smith also said "if we don't get our way...." and then he picked up my matches from the table and said "four days". From this I take took him to mean that if he did not manage to put an end to Pacific Resorts Limited's operations on Anuha Island he would set fire to the place. I replied that I wished he had not told me this information.
