CRIMINAL CASE HYPOTHESIS.

- A. Fraudulent Transfer of Anuha Island and other properties covered under the terms of my irrevocable, unlimited and exclusive power of Attorney.

Respondents:-

1. Attorney General and Office of the Attorney General (Registrar of Titles)- *Having fore knowledge of my irrevocable, unlimited and exclusive terms my power of Attorney yet influenced the Donee to fraudulently transfer Anuha to the Government of the Solomon Island.*
 2. Government of the Solomon Island - *A party to the fraudulent transfer as lessee.*
 3. Estate of the late Father Robert Pule the donee of my Power of Attorney as:
 - i. *Party on the other part of the illegal transfer of properties under my power of Attorney.*
 - ii. *Reportedly, signed a revocation to my power of Attorney contrary to section 125,126 of the Property Act of the Laws of the Solomon Islands.*
 4. Australia High Commission, Honiara - *For witnessing the illegal transaction of fraudulent transfer of Anuha in a publicised public event even after been aware and I personally reminded the High Commissioner that I have the power of attorney over the property.*
- B. Falsification of evidences resulting in the Court of the Solomon Island issue a prohibition order banning me from entering a property covered under the terms of my Power of Attorney.

Respondents:-

1. Commissioner of Police - *In colluding with Page one Television crew the Police wrongful charge me resulted in the issue of the restraining order. Though the Police investigation in Brisbane and in Honiara has cleared me no cancellation has ever been made to the restraining order.*
2. Page one- Television Crew - *Clipping/ editing a documentary on Anuha implicating that I had breached the restraining order.*

CIVIL CASE HYPOTHESIS**Respondents:-**

1. **Government of the Solomon Islands** – *Denial of liberty to enter the Solomon Islands to commence business in developing economic projects of properties covered under my Power of Attorney and those prospects under my own personal contacts while employed as executive Chief of Anuha Island Resort.*
 - a. Loss of earnings as an expatriate Tourism Industry Executive in the Pacific Islands *due to personal and professional credibility severely damaged as result of fraudulent chargers against me which has since 1997 cleared by Solomon Island Police but still gathering dust at the Solomon Island DPP.*
 - b. Loss of possible revenue from developing Anuha Island Resort *which at that time was the jewel of Solomon Islands Tourism.*
 - c. Loss of earnings as a Tourism Industry Executive in Australia, *my last posting before Solomon Island was as Executive Chef at Hamilton Island, a premier tourism destination, due to personal and professional credibility severely damaged as result of fraudulent chargers against me. Embarrassingly, Federal Hansard records that my name was openly ridiculed by the Labour Foreign Minister Senator G. Evans under protection of Parliamentary immunity.*
 - d. Defamation of my character.
 - e. General damages, pain and misery caused to my partner and I *that have now have obvious toll on our physical and psychological health and well being.*
2. **Commissioner of Police** – *through the Assistance Commissioner of Police declared my innocence of all matters a letter the Police wrote to me. The Police conclusion was based on their own investigation here in Brisbane and in Honiara, yet no action on the Police part was attempted to cancel the fraudulent charges.*
3. **Page one- Television Crew** – Loss of earning.
4. **Director of Tourism** – Encouraging development on Anuha with out my consent.

PROFFESIONAL MISCONDUCT AND PROCASTINATION.

1. **Ombudsman of the Government of the Solomon Island:**
Though under his jurisdiction chose not to investigate the nine Government Offices and agencies for their fraudulent activity, incompetence, wilful procrastination. Please see attached herewith copy of the 55 pages complain to the Ombudsman.
2. **Australian Ministry of Foreign Affairs.** After numerous communications over the years no action has been made to assist me as an Australia Citizen. Only response was from Mr. Michael Bliss, Director International Law and Transactional Crime in January 2005. My latter to RAMSI the Australia funded and man administrator in Honiara has not been responded to.
3. **Australia Federal Police.** In the hight on my persistent and pressuring the Government of the Solomon Island to settle my case in, after the successful completion of their own Police investigation, a member of the Federal Police visited me in my residence with instruction to retrieve the original copy of my Power of Attorney.
4. **Prime Minister of the Solomon Island.** After personally meeting Sir Allan Kamakeza here in Brisbane with promises that he will settle instruct the DPP to with draw the fraudulent charges against me no action has been made.
5. **Assistant Commissioner of Police- Crime and Prosecutions –** meeting him on two occasions here in Brisbane with promises and even a letter stating my innocence nothing concrete had been done. He charged me \$10,000.00 for the cost of a copy of the Police report that had vindicated me. (Original copies of both letters are in my possession.
6. **Minister of Justice, Police and Security –** Visited me twice in my place of business, thoroughly discuss my case and gave assurances that he will present it to Cabinet for settlement in the best mode possible.
7. **Registrar of the High Court of the Solomon Islands –** for choosing to disallow my application to be Administrator of the Estate of Father Pule as I hold the irrevocable, unlimited, exclusive Power of Attorney. In his ruling he admits sighting copy of the Power of Attorney. My legal counsel, a Solomon Islander whose fees was fully paid, withdrew at the last minute resulting in a non appearance of my representative.
8. **Law Society of the Solomon Island –** Failed to investigate my complaints of the numerous member of their Society who have been send money and not done any work.
9. **Chief Justice –** Wrote him a letter of complin against my experience with the pathetic legal system in the Solomon Island. No reply after three years.
