JOHN SMITH SAYS: Gov't Stunned Over Lifting of Prohibition Order

'I'M NOT A REBEL'

Holder of Irrevokable Power of Attorney over Anuha Island Resort Arriving Soon

AN AUSTRALIAN prohibited from entering the country for almost 25 years, John Smith said he will be revealing all the discrepancies that took place in the country's top echelon that led to the downfall of the tourism industry.

He dispelled being labeled a rebel when a prohibition order was imposed on him in 1988 from entering the country.

Mr Smith said he has not done anything wrong when he was in the country and that he was merely acting in the interest of Anuha landowners because he does not want to see the landowners being robbed of their right over the island.

"I am not a rebel but a peace loving man who want to help Solomon Islanders.

"Upon my return to Solomon Islands I will reveal all the rot that has taken

place over the Anuha island row.

I have all the documents to prove my case.

"I was not wanted back in the country in 1988 because I hold the 'irrevocable power of attorney' over Anuha Island and I will not give it to anybody as required of me by principle landowner of Anuha, late Fr Robert Pule.

Mr Smith said during his 25 years absence from the country, Anuha Island was sold fraudulently four times, the latest being to SkyAir World who later went bankrupt.

He said he was the one responsible for blocking SkyAir World redeveloping Anuha resort with his 'power of attorney' after they wish to obtain a loan of \$20 million using Anuha Island as collateral.

Mr Smith told this paper he will be visiting the country in

two to three weeks time just like he did four times last year to help build the economy of Central Islands Province.

Meanwhile, the Offices of the Prime Minister and Attorney General's Chambers were stunned to have learnt from Island Sun as to how the prohibition order on Mr Smith was lifted allowing him to return to the country.

An investigation is being conducted by Government to ascertain the lifting of Mr Smith's prohibition order although Island Sun is well aware the prohibition order was lifted in a Government Gazette on December 1991.

In 1988 Anuha resort was categorised a three star resort before its forced closure after landowners were not happy with the way the island resort continue to change ownership without the knowledge of the landowners.

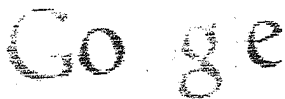
